It was further resolved that Dr. Praveen Kumar would prepare within a fortnight, the norms for qualification and experience of STA coordinator and STA/PTA team members and submit them for the consideration of NRRDA.

## Item No. 2 Opening of New Heads of Accounts in Chart of Accounts for PMGSY Programme for States to book the expenditure on 'RRNMU and RCTRC' in OMMAS

Jt. Director(F&A) explained to the Executive Committee the need for opening of New Heads of Accounts in Chart of Accounts for PMGSY Programme for the States, to book the expenditure on 'RRNMU' and 'RCTRC' in OMMAS. Further Executive Committee was informed that ADB financial support under Rural Connectivity Investment Programme for these units (i.e. RRNMU and RCTRC), will be 80% for the civil works and 100% for equipments, Government of India's contribution will include rest of civil works (20%) and all the recurring cost including cost of providing land will be borne by State Government. To a query raised by Consultant Finance as to MoRD's approval for construction of RRNMU and RCTRC, the Executive Committee was informed that requisite approval of 20% finance for civil works of RRNMU and RCTRC, by Government of India has been obtained from the then AS&FA
