- 2. Uttar Pradesh Rural Road Development Agency (UPRRDA) requested this Ministry to revise the above mentioned clearance proposal on the ground that State has wrongly calculated the project cost of five roads of Gorakhpur district (Package no. UP-31155, UP-31156, UP-31157, P-31158 & UP-31159) and accordingly made the wrong entry of projects costs in OMMAS for the above projects which would lead to loss of Rs.1294.29 Lakh(Rs.2457.13 lakh-Rs. 1162.84 lakh) for UPRRDA and they will not be able to complete these projects due to short supply of funds.
- 3. The matter has been examined in the Ministry in consultation with NRIDA and the request of the State to revise the clearance proposal under **PMGSY-III Batch-II 2021-22** has been found to be in order. Accordingly it has been decided with the approval of the Competent Authority to revise the project cost of the above batch as under:-
