MINUTES OF THE MEETING OF THE EMPOWERED COMMITTEE FOR PMGSY HELD ON 15th FEBRUARY, 2013

STATE: ANDHRA PRADESH

A Meeting of the Empowered Committee (EC) was held on 15th February, 2013 at 03.30 PM under the chairmanship of Secretary, Department of Rural Development to consider the proposals of the State of Andhra Pradesh pertaining to 4 IAP Districts (Vizianagaram, Visakapatnam, Adila and Warangal) under Pradhan Mantri Gram Sadak Yojana (PMGSY).  A detailed presentation was made by NRRDA on the present status of implementation of PMGSY in the State of Andhra Pradesh and the current proposals.

- 4. The Empowered Committee reviewed the progress since the previous Empowered Committee Meeting held on 26.7.2012 and considered the institutional enpucity of the State to efficiently execute the PMGSY works with the requisite attention to quality. The Empowered Committee also considered achievements under PMGSY, public disclosure norms in terms of the physical and timancial and accounting data entered by the State in the programme software, Quality Monitoring, OMMAS and the diligence in maintenance of the high quality assots created under the programme for the long term reduction of poverty.
- 5. While reviewing the current proposals, the Empowered Committee also reviewed the pace of implementation of road works under PMOSY in the State. The State has reported to have completed 6135 works out of 6196 works, which were sanctioned prior to March 2010 and 61 works (1%) are still incomplete. The State was advised to send the completion plan for the left over works to the Ministry.
- 6. It was observed that DPRs in respect of 21 road works sanctioned by MoRD in previous phases have not yet been approved by STAs on OMMAS. The State informed that approval of STAs has been obtained for 18 DPRs. The State was advised to get the on-line approval of STAs for remaining DPRs immediately.
- 7. It was also observed that data entry gaps still persist on the selected parameters on the MMAS. It was reiterated that the data should be fed into OMMAS on a regular basis. The State should close data entry gap on OMMAS within 10 days as agreed by it. It was also observed that number of habitations covered under the State Scheme has not been entered in OMMAS.

8. Maintenance:

8.1. The details of maintenance funds required released to SRRDA and utilized by them during the last two years and current year is given below.

8.2. The State informed that ar amount of Rs. 48.68 has now been credited to SRRDA exclusively for maintaining PMGSY roads. The Committee observed that the State did not spend as per the requirement on maintenance of roads constructed under PMGSY. The State was advised to prepare a comprehensive maintenance plan for maintaining the assets created under PMGSY. The Committee desired that the State Government's attention be drawn to the provision of para 17.1 of PMGSY Guidelines regarding maintenance which states that "the putting in place of institutional measures to ensure systematic maintenance and providing adequate funding for maintenance of the rural. Core. Network, particularly the Through Routes, will be the key to the continuance of the PMGSY programme in the State".

9. Quality:

- 9.1. The State has reported that field level laboratories have been established in all the 22 districts. The Committee advised the State that the SQC and Chief Engineer should inspect at least 10% laboratories every quarter.
- 9.2. Out of 804 SQM inspections during the period April 2011 to December 2012, unsatisfactory reports were reported for 9% at ongoing stage and 1% at Completed Stage. The reports of NQMs show that the quality of the roads is not upto the expected level and charing the period April 2011 to December 2012 a high number of unsatisfactory works have been reported by NQMs (5% at on-going stage and 18% at completion stage).
- The Committee abserved that the SQMs are serving officers of the same Department. The Committee abserved that engaging SQMs from the implementing agency would amount to conflict of interest as it will defeat the very purpose of the independent nature of the reporting system. The Committee advised the State Covernment to immediately change the system so as to ensure independent monitoring under 2nd tier quality mechanism.
- 9.3. As regards submission of ATR on NQM inspections, out of 69 ATRs required to be submitted, the State has submitted ATRs on 47 reports only. The State is required to submit ATR for remaining 22 reports. It was further decided that for unsatisfactory works identified by NQMs (non-rectifiable defects), the amount incurred should be recovered from the State.
- 9.4. The State has uploaded 6951 photographs on OMMAS based on 804 SQM inspections made during the period April 2011 to December 2012. SQMs are required to upload 10 photographs, including one of field laboratories, on each inspection.
- Further, the Empowered Committee made following observations on the current proposals:

10.1. DPR issues:

- Proposals entered are not matching with the current proposals.
- All proposals have not been scrutinized by STAs online.
- Average construction cost is on the higher side.
- iv. Provision made for Maintenance for the current proposal is on lower side. It should be a minimum 7-5% of the proposed cost estimate.
- v. A few ineligible proposals of habitations less than 250 populations included, though the State informed that these habitations have been covered under cluster, the details of cluster have not been updated on OMMAS.
- Only 9 roads have been probased under R&D and DPRs of these roads have not been sent to NRRDA along with current batch of proposals.
- vii. Latest SoR has not been vetted by NRRDA, because it was given by the State only on the date of meeting, though proposals is as per new SoRs.
- Joint inspection (SE & STA) reports of long span bridges have not been provided by the State.
- ix MP1, 11,111 formats have not been received for final list of road works

11. Absorption Capacity

11.1. The financial report of the programme indicates that the expenditure incurred by the State for construction of road works under PMGSY is very low. Also, the State had a huge unspent balance which was to the time of Rs.444.83 crore at the end of the last

financial year, i.e. 31st March, 2012. As per the capacity assessment study (based on ongoing works, number of SQMs, average expenditure and no. of PIUs) the State has been assessed to take up additional works of Rs. 1500 crore, which also include the present proposals with the Ministry.

12. Financial/Accounting Issues

- 12.1 An unauthorized expenditure on plantation of Rs.7.92 lakly incurred.
- 12.2 Diversion of an amount of Rs.8.47 lakh from programme fund to Admin. Fund
- 12.1 An amount of Rs.4.41 crore has been booked under 'Other Funds' in the liability side of balance sheet.
- 12.4 Out of 6346 works completed, financial closure has been made for only 5388 works.

13. Recommendation of Empowered Committee

- 13.1. Subject to the above observations, the Empowered Committee recommended the above proposals for consideration under PMGSY.
- 13.2. Further, as agreed by the State representatives, the State will complete following activities, prior to clearance.
 - All proposals should be scrutinized and approved by STAs on OMMAS
 - Road lists along with district abstract after making necessary corrections based on the observations of the Committee should be provided to the Ministry in a soft copy.
 - Completion plan for all left over works sanctioned prior to March 2010 should be submitted to the Ministry.
 - iv. DPRs of road works already sanctioned by the Ministry in the previous phases should be vetted by the STAs on-line.
 - v. Out of 69 ATRs required to be submitted, the State is yet to submit ATR on 22 reports. Urgent remedial action should be taken for these 22 cases and ATRs on NQM reports should be sent to NRRDA and uploaded on OMMAS.
 - vi. The State will update the entries on OMMAS to keep the data entry atleast at 95 %.
 - Joint inspection (SE & STA) reports of long span bridges should be provided to NRRDA.
 - viii. Provision of minimum 7.5% should be made for maintenance under the current proposal
 - Accounts for programme funds should be reconciled with OMMAS entries and the balance sheet for the year 2011-12 should be prepared through OMMAS and should reconcile with audited balance sheet. For the year 2012-13 the accounts should be made only OMMAS generated balance sheet and same should be duly audited. For Admin. fund and maintenance fund also OMMAS based accounts should be prepared.
 - x. DPRs of 6 road works, which were sanctioned during Phase X (Batch-I) under R&D technology should be sent to NRRDA for scrutiny after duly vetted by STAs.
 - Mandatory certificates like land clearance certificates etc. should be provided.
 - xii. Soft Copy of Proposals in DVD should be sent.
 - xiii. MP LII and III formats for final list of road works should be sent to NRRDA.

14. Following activities will be completed by the State before tendering the works.

- All the DPRs proposed under R&D technology in the current batch of proposals including some granitic gravel based, should be sent to NRRDA after duly vetted by STAs.
- II. The 2nd fier monitoring a echanism should be strengthened in order to ensure independent quality inspections.
- III. The State has to prepare a comprehensive Maintenance Plan to ensure that the assets created under PMGSY are maintained up to the standard.
- iv. Financial closure of 80 % of the road works tendered up to March 2010.
- v. Expenditure of atleast 50% of the balance fund for the year.
- vi. Printing of road lists as on 1.1.2013 along with columns on maintenance budget and expenditure
- vii. Costs would be duly reduced as per observations of NRRDA. Moreover, these would be further reduced commensurate with SoRs not approved to the extent by NRRDA.
- viii.Mnintenance back log at least Rs.2.09 crores (78.68 48.68 -27.91) would be credited to SRRDA'S maintenance account.
- xi, Joint inspection of balance LSBs. (of 15 m. or more) would be carried out by STAs and SEs.
- The meeting ended with a Vote of thanks to the Chair.
