Subject: Release of Financial Incentive under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Gujarat for the year 2023-24-reg.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 27,15,00,000/- (Rupees Twenty Seven Crore and Fifteen Lakh Only)** to the State of Gujarat for “**Financial Incentive**” as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2023-24**.

2. **These funds are exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana.**

3. **The State Government shall transfer these funds along with the corresponding State share of Rs. 18.1 crore to Gujarat State Rural Roads Development Agency (GSRRDA) within a maximum period of 30 days from the date of receipt of these funds. In case of delay beyond 30 days in transfer of central share to the SNA account, interest will be charged at the rate of 7% per annum. The State Government is required to endorse a copy of the release order to the Government of India at the following address:**

4. **Gujarat State Rural Roads Development Agency (GSRRDA), has nominated Shri Y. M. Chavda, Chief Engineer (PMGSY) as the Empowered Officer of GSRRDA.**

5. **The funds transferred by the State Government to GSRRDA shall be kept in a separate Saving Bank Account No. 10354902014 in State Bank of India, (IFS Code- SBIN0008434), New Sachivalaya Branch, Block No. -3/2, Sector-10A, Gandhinagar, Gujarat- 382010. Implementing Agencies (IAs) down the ladder should use the SNA's account with clearly defined drawing limits set for that account. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana as per the limit assigned. The Empowered Officer of the Gujarat State Rural Roads Development Agency (GSRRDA) shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.**

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Gujarat State Rural Roads Development Agency (GSRRDA)**.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose

9. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in term of **Rule 230(8) of GFR, 2017**. Interest earned should be clearly and separately depicted in PFMS, scheme- specific portals integrated with PFMS and in MIS provided by the banks.

10. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.

11. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.

12. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of **Rule 236(1)** of the General Financial Rules.

13. The expenditure is debitale to the following Head of Accounts under **Demand No. 87** Department of Rural Development (**2023-24**).

14. Secretariat of the Election Commission of India, New Delhi has stated that release of financial incentives under PMGSY would be subject to following condition:-

(i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever,

(ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.

(iii) These restrictions on publicity will be applicable to the Central Government as well as the State Governments concerned.


(iv) The relevant provisions of Model Code of Conduct issued by the Commission shall be strictly followed.

(v) No new work shall be taken up afresh during MCC period.

15. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to **State Government of Gujarat**.


16. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their U.O No .1425/Finance/2023-24 dated 28.03.2024.
