The State Government must transfer these funds to Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPLWEA) Scheme under R&B Department within a maximum period of 30 days from the date of receipt of these funds. In case of delay beyond 30 days in transfer of Central Share to the SNA account, interest will be charged at the rate of 7% per annum. - 4. Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPL WEA) Scheme under R&B Department has nominated Shri Pingali Satish, Chief Engineer (R&B) Admn,Q.C,D&P, LWE, RSW & RR & Empowered Officer, TSRCPLWEA.
- 5. The funds released by the State Government shall be kept in a separate saving Bank Account No. 37594497421 (IFSC Code- SBIN0013272), State Bank of India, Erragadda Branch 13272, #5-264, Beside SriRamulu Theatre, Prem Nagar, Erragadda, Hyderabad-500018. Implementing Agencies (IAs) down the ladder should use the SNA's account with clearly defined drawing limits set for that account. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana as per the limit assigned. The Empowered Officer of the Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPLWEA) Scheme under R &B Department shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.
- 6. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Telangana Road Connectivity Project for Left Wing Extremism Affected Areas (TSRCPLWEA) Scheme under R&B Department.
- 8. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on prorata basis in term of **Rule 230(8) of GFR, 2017.** Interest earned should be clearly and separately depicted in PFMS, scheme-specific portals integrated with PFMS and in MIS provided by the banks.
- 9. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.
- 10. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.
- 11. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236(1)** of the General Financial Rules.
